

APPLICATION FOR ENROLLMENT AS A RECORDED "r" JUDGE

All material submitted to the Licensed Officials Committee, including applications, evaluations, questionnaires, letters received regarding applicants or officials, competition reports and other relevant information shall be strictly confidential. By submitting this application, the applicant specifically waives his/her rights to examine such submissions.

Learners may apply only when the requirements for promotion have been met. See ADS Handbook.

Article 130.2-5: "2. Applicant must provide evidence of knowledge and experience in the classifications for which he is applying either as a competitor, trainer or competition official, such as Judge, Technical Delegate or Organizer of Driving Events of other similar horse related activities or must have completed an ADS Training Program. The applicant will also be evaluated on character and temperament to adjudicate. 3. Applicant may be required to take an open book test and must pass with a score of 85% or greater. 4. Applicant must attend at least one approved ADS sponsored Clinic in the classifications for which he is applying and/or be evaluated by an Examiner approved by the Licensed Officials Committee and satisfactorily complete the written and/or practical requirements thereof. 5. No application for approval as a Recorded Judge will be considered by the Licensed Officials Committee until the applicant passes a test if required and works as a Learner with a Registered or Recorded Judge at a minimum of 2 ADS approved competitions. Evaluations of the applicant from the ADS officials at these competitions must be completed and returned to the ADS.
